ELIGIBILITY

Candidates for admission to the Ph.D. programme should have a Master's degree from a University recognized by UGC or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized.

A relaxation of 5% of marks from 55% or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC/Differently-abled as per the decision of the university.

Entrance Test Pattern

The Candidate has to appear for an entrance test in which the candidate should secure minimum qualifying marks of 50% to be eligible for Ph.D. admission. Candidates who secure less than 50% in the entrance exam shall not be eligible for inclusion in the consolidated merit list under any circumstances.

The entrance examination shall be for 100 marks. Section A consists of 50% questions evaluating research aptitude, analytical skills, writing skills, comprehension and reasoning and Section B consists of 50% of questions on discipline specific expertise.

As per the University Grants Commission (UGC) notification dated March 27, 2024, Garden City University will accept the National Eligibility Test (NET) score for the NET cleared candidates and they are exempted from taking up entrance exam for Ph.D. admission. However, the candidate need to apply in the prescribed format with NET certificate before the last day.

Nature of Questions: Multiple Choice Questions

Duration of Entrance Examination-120 minutes

All those candidates who take up interdisciplinary topics for research have to compulsorily appear for the entrance test in the respective department where the candidate has applied.

General Instructions

Attested copies of degree certificates, marks sheets, caste certificate, equivalence certificate and other relevant documents should be enclosed.

Those who are employed, should submit their application form along with No objection certificate from the employer. Incomplete or application not in the prescribed form will be

All Ph.D. applicants are required to assist in teaching, research and/or administrative work as assigned by the respective academic department for a minimum 8 hours of work per week.
